

2024 Proxy Resolutions and Voting Guide, ICCR, 2/15/24

### SEC Lawsuit Update

In June 2021, ICCR, As You Sow and James McRitchie filed a lawsuit seeking to overturn changes to Rule 14a-8, passed in the late days of the prior administration, which limits the ability of shareholders to file resolutions. (See the full timeline of events here: https://www.iccr.org/timel ine-of-the-investorcampaign-to-preserverule-14a-8/). The court has postponed a scheduled status hearing nine times. Most recently, the status hearing has been

### postponed to May 2024.

### Exxon Suit Should Prod SEC to Tighten Shareholder Proposal Rules

ExxonMobil Corp. recently attracted significant attention after suing Arjuna Capital and Follow This, two climate activists who sent a shareholder proposal asking that the company set stringent targets to slash its greenhouse gas emissions and those of its customers. However, shortly after being confronted with the prospect of having a court of law review whether their proposal was legal, the activists decided to withdraw their shareholder proposal. Even after the investors withdrew their resolution, Exxon said that while it would drop a request for an expedited hearing, it would press forward with the Lawrence Cunningham, **Bloomberg**, 2/15/24 Myles McCormick and Tom Wilson, **FT**, 2/2/24 case.

## Key Trends this 2024 Proxy Season

- 344 proposals filed at 215 companies.  $\geq$ Human rights, the climate crisis, and
- corporate political activities continue to dominate investor concerns.
- Artificial intelligence (AI) is emerging as a growing investor concern.
- Worker rights provisions such as the adoption of a living wage policy, collective bargaining rights, and paid sick leave see more proposals.
- A continued focus on human rights abuses in conflict-affected high-risk areas (CAHRA), including Uyghur forced labor in the renewable energy sector and the Russian invasion of Ukraine.

### House Judiciary Committee **Issues Subpoena to Silence** Shareholders

On November 1, 2023, As You Sow, the nation's leading shareholder advocate, received a subpoena from the House Judiciary Committee demanding the organization provide documents related to its work with companies related to climate risk. This follows an August 1 letter from the Committee arguing that "As You Sow is potentially violating U.S. antitrust law by entering into agreements to 'decarbonize' corporate assets and reduce emissions to net zero - with potentially harmful effects on Americans' freedom and economic well-being."

## 2024 Shareholder Resolutions: Descriptions

Report on Tax Transparency - Requests a report due to the lack of corporate tax transparency and the impact of tax avoidance.

Amend Artificial Intelligence Principles and Board Oversight Report — Requests the Board of Directors amend the charter of the Audit and Compliance Committee of the Board to make it clear that the Committee is responsible for overseeing artificial intelligence activities.

Prepare a Living Wage Disclosure Report — Requests the preparation of a living wage report to provide investors with information needed to assess the extent to which the Company is complying with international human rights standards and assessing systemic risks stemming from growing income inequality.

Publish Climate Transition Plan — Requests the creation of a climate transition plan describing how the company intends to align its operations and full value chain emissions with the ambition of limiting the global temperature increase to 1.5°C.

Assess and Report Risks on Online Sexual Exploitation of Children — Requests that the company publish a report assessing risks of its products and services being used to facilitate online sexual exploitation of children.

Amend Code of Ethics — Asks the Board of Directors to amend the publicly available Code of Ethics by expanding the topic "Inclusive & Respectful Work Environment" and to issue a report on how the Board of Directors checks and verifies board member compliance with the amended Code of Ethics.

### Inflation Reduction Act funding helps a Dane County monastery upgrade to clean energy

Thanks in part to President Joe Biden's signature infrastructure law, the Inflation Reduction Act, the Benedictine Sisters of Holy Wisdom Monastery located in Middleton, Wisconsin, are in the process of making several upgrades to their property that will help the monastery become powered entirely by renewable energy by the end of 2024. In 2023, Holy Wisdom began a three-part clean

In ŽÓ23, Holy Wisdom began a three-part clean energy project, first installing a 300-kilowatt ground-

mounted solar array, then building a battery storage system for that power, and finally replacing a natural gasfired HVAC system with a geothermal well-based system.



The combined cost of the three projects was estimated to be just over \$3 million. The new installations will not only allow them to reduce energy costs, but will also give them more reliable heating and cooling.

Hungry fish faithfully entertain newcomer guests! With the introductions

complete, Sister Hyacintha began learning aquaponic methods for a full day from Lauren R. Manders who has taught fish farming in New Orleans for years and traveled abroad starting aquaponics systems in other countries.

After Sister Hyacintha's visit to Phil Reasons creative farm in Dade City, he continued her training explaining types of systems which could be introduced in her native country. The reasons for having sustainable aquaculture farming are so many—food security and poverty, and can be summarized in one comment Sister made about commercialized food, "Food here is tasting good, but is destroying our body." # TO HOPE AND ACT WITH CREATION

SEASON OF CREATION 2024

The firstfruits of hope (Rom 8:19-25)

The Season of Creation is the annual Christian celebration to pray and respond together to the cry of Creation: the ecumenical family around the world unites to listen and care for our common home. The "Celebration" begins September 1, the Feast of Creation, and ends October 4, the Feast of Saint Francis of Assisi, the patron saint of ecology beloved by many Christian denominations.

The theme for Season of Creation this year is To Hope and Act with Creation, and the symbol is The firstfruits of hope, inspired by Romans (Rom 8:19-25).

The biblical image pictures the Earth as a Mother, groaning as in childbirth (Rom 8:22). Saint Francis of Assisi understood this when he referred to the Earth as our sister and our mother in his Canticle of Creatures. The times we live in show that we are not relating to the Earth as a gift from our Creator, but rather as a resource to be used. "Creation is groaning" (Rom 8:22) because of our selfishness and our unsustainable actions that harm her. Along with our Sister, Mother Earth, creatures of all kinds, including humans, cry out because of our destructive actions causing climate crisis, loss of biodiversity, and human suffering as well as Creations suffering.

And yet Creation teaches us that hope is present in the waiting, in the expectation for a better future (cf. Rom 8:20-21). To hope in biblical context does not mean standing still and quiet, but rather groaning, crying, and actively striving for new life amidst the struggles.

Creation and all of us are called to worship the Creator, working together for a future of active hope and action. Only when we work together with Creation can the firstfruits of hope be born. Just as in childbirth, we go through a period of intense pain, but new life is coming forth.

## Russia's War On Ukraine - Two Years On

## Reconstruction Cost

The reconstruction and recovery in war-torn Ukraine would cost \$486 billion over the next decade, up from \$411 billion estimated a year ago.

## Senate Bill 3 and Senate Bill 4 (SB4)

- Senate Bill 3 earmarks \$1.54 billion in state money for the construction of barriers along the Texas-Mexico border and allows the state to spend up to \$40 million for state troopers to patrol Colony Ridge, a housing development near Houston, TX, that publications claim is a magnet for immigrants.
- Senate Bill 4 creates a state crime for illegally crossing the border from Mexico. The new state crime is a Class B misdemeanor carrying a punishment of up to six months in jail. Repeat offenders could face a second-degree felony with a punishment of two to 20 years in prison.
- On March 26, a federal appeals panel declined to put Texas's migrant deportation law SB4 back in effect, saying the state law seizes powers that are "likely reserved to the United States." The 2-1 opinion from the 5th Circuit Court of Appeals keeps the law on hold while a broader legal battle plays out over the constitutionality of the state's new immigration enforcement scheme. The appeals court is scheduled to hear arguments in the case on April 3, 2024.
  - On April 3, an attorney defending Texas' plans to arrest migrants who enter the U.S. illegally told a panel of federal judges that it's possible the law "went too far" but that will be up to the court to decide.

## **Annunciation House**

- The Texas Attorney General's (AG) office sued to shut down Annunciation House, a Catholic nonprofit, that helps shelter migrants in El Paso, TX.
- Officials from the AG's office visited Annunciation House on February 7, 2024 demanding it provide extensive documentation within the last 24 hours that includes the identities of all migrants the organization has helped. The administrative subpoena sent to Annunciation House demanded some of the organization's documents from January 2022 until February 2024.
- An attorney representing Annunciation House filed a lawsuit on February 8, 2024 to delay the release of the records and examine the legality of the AG's request.
- The AG's office filed a counterclaim accusing Annunciation House of engaging in human smuggling.

## Gun Makers to Ask U.S. Supreme Court to Bar Mexico's Lawsuit

U.S. gun manufacturers plan to ask the U.S. Supreme Court to hear their bid to escape Mexico's \$10 billion lawsuit seeking to hold them responsible for facilitating the trafficking of weapons to drug cartels across the U.S.-Mexico border. Mexico alleges in the lawsuit, filed in 2021, that the companies undermined its strict gun laws by designing, marketing and distributing military-style assault weapons in ways they knew would arm drug cartels, fueling murders, extortions and kidnappings in the country. Mexico says over 500,000 guns are trafficked annually from the U.S. into Mexico, of which more than 68% are made by the eight companies it sued, including Sturm, Ruger & Co, Beretta USA, Barrett Firearms Manufacturing, Colt's Manufacturing Co and Glock Inc. # Catholic bishops meet with Mexico's cartel bosses to plead for peace

Citing a "profound crisis of violence and social disintegration," Mexico's Catholic bishops are staking out an aggressive new role in national security, going so far as to sit down with feuding drug traffickers in one bloodsoaked state to hammer out a truce. Church leaders recently persuaded the candidates in the July 2, 2024 presidential election to sign a "National Commitment for Peace" that includes a lengthy list of proposed reforms, such as strengthening local police forces and making the justice system more professional and transparent. The church is acting now, Bishop Ramón Castro says, because it has received complaints from parishioners who have suffered extortion, robbery and the disappearance of loved Ones. ### U.S. struck with historic number of billion-dollar disasters in 2023

In 2023, 28 confirmed weather/climate disaster events with losses exceeding \$1 billion each affected the United States. These events included: 1 drought event, 4 flooding events, 19 severe storm events, 2 tropical cyclone events, 1 wildfire event, and 1 winter storm event. The total cost for these 28 disasters was \$92.9 billion, but that may rise by several billion dollars when the costs of the December 16-18, 2023, East Coast storm and flooding event are fully accounted for. ### How the 2024 Total Solar Eclipse Is Different than the 2017 Eclipse

- In 2017, the path of the solar eclipse ranged from about 62 to 71 miles wide. During the April eclipse, the path over North America will range between 108 and 122 miles wide.
- An estimated 31.6 million people live in the path of totality this year, compared to 12 million in 2017. An additional 150 million people live within 200 miles of the path of totality.
- In April, totality will last longer than it did in 2017. Seven years ago, the longest period of totality was experienced near Carbondale. Illinois, at 2 minutes, 42 seconds.


