Trump issues a slew of immigration-related executive orders on first day of new term

- Halt all refugee admissions into the United States until policy "aligns" with U.S. interests

- Require immigrants unlawfully in the United States to register and be fingerprinted

ACLU files lawsuit against Trump order that seeks to end birthright citizenship

- On January 20, 2025, advocacy groups, led by the American Civil Liberties Union (ACLU), filed a federal lawsuit against President Donald Trump's executive order to halt the automatic granting of citizenship to children born in the United States. The order denies citizenship to children born in the U.S. if their mothers were unlawfully present or temporarily lawful, and the father wasn't a citizen or legal permanent resident.

Twenty-two States Sue to Stop Trump's Birthright Citizenship Order

- Attorneys general from 22 states have sued President Trump to block an executive order that refuses to recognize U.S.-born children of unauthorized immigrants as citizens. Eighteen states and two cities filed a lawsuit in Massachusetts, arguing that birthright citizenship under the 14th Amendment is automatic. Four other states filed a second lawsuit in Washington. Signed by Trump on his first day back in office, the order declares that future children born to undocumented immigrants will not be treated as citizens. The order extends to children of some legally present mothers, such as foreign students or tourists. The order could deny citizenship to 150,000 newborn children each year. The order does not take effect for 30 days, allowing executive-branch agencies to prepare while courts decide on its legality.

Trump shuts down immigration app, dashing migrants' hopes of entering U.S.

- The CBP One app was a mobile application introduced by the Biden administration to streamline the asylum process for migrants. It allowed migrants to notify the U.S. government of their intention to arrive at a port of entry and schedule appointments to seek asylum. This system aimed to create an orderly process and reduce illegal border crossings. President Trump canceled the CBP One app on his first day back in office. The app's functionalities were discontinued, and all existing appointments were canceled. CBP said that in December, it processed about 44,000 asylum-seekers through information submitted through the app. From Jan. 2023 to Dec. 2024, more than 936,500 people had scheduled appointments, CBP said.

Trump shuts off access to asylum, plans to send 10,000 troops to border

- President Donald Trump is preparing to send around 10,000 troops to the southern border, where they will support Border Patrol agents under new orders to shut off access to asylum. The order directs border agents to block entry to migrants on the grounds that they have passed through countries where communicable diseases are present, without citing any specific health threat. The Defense Department will send at least 1,500 additional active-duty ground troops to the southern border in what could be the first of several waves of deployments, said acting defense secretary Robert Salesses. Those forces will bolster about 2,500 who already were there. On January 23, 2025 the Pentagon said it has begun deploying 1,500 active duty troops to help secure the southern border.

Trump's order seeking to block birthright citizenship to face next legal hurdle

ACLU files lawsuit challenging Trump's move to close U.S. asylum system

Here are the cities where ICE raids are taking place

- Following President Trump's return to office, ICE has intensified immigration enforcement operations in major U.S. cities. On Sunday, January 26, ICE arrested 956 people, although an NBC News report found nearly 1,200 arrests, with only 613 considered "criminal arrests." The following day, ICE reported 1,179 arrests and 853 detainers. Since the inauguration, there have been at least 4,829 arrests, averaging 753 per day, compared to 282 under the previous administration. ICE aims to conduct major raids in three cities per week, with recent operations in Chicago, New York City, and other major cities.

ICE to conduct major immigration operations in three cities per week

- Federal enforcement agencies are targeting three U.S. cities per week for large-scale immigration arrests, with Aurora, Colorado, next in line. This week, ICE and other federal law enforcement agencies began operations in Chicago on Sunday and New York City on Tuesday. Acting ICE Director Caleb Vitello directed field offices to increase daily arrests to a goal of 1,200 to 1,500, leading to more "collateral arrests" of migrants with no criminal records. By the numbers: A look at how recent immigration arrests compare to past efforts

- President Trump's administration has intensified immigration enforcement, leading to a significant increase in arrests of undocumented individuals. Since January 22, ICE has arrested over 8,200 people, with a daily average of 827 arrests—more than double the previous year's daily average of 310. The Dallas ICE office led the nation with 10,450 arrests in fiscal year 2024. Experts are concerned about the accuracy of the rapidly reported daily statistics, and while the focus is on public safety and national security threats, the data does not specify how many arrested had criminal histories. The U.S. saw a record influx of over 2.8 million international migrants in 2024, with Texas receiving about 320,000.

Immigration arrests in churches? Some clergy say not so fast

- With the Trump administration allowing immigration agents to make arrests in places of worship, faith leaders in Southern California are prepared to aid and shelter immigrants. Guillermo Torres of Clergy and Laity United for Economic Justice emphasized their commitment to love and support their neighbors. This new policy rescinded a 2011 memo restricting arrests in sensitive locations. Some faith groups, like Quaker congregations, have sued the Department of Homeland Security, citing harm to religious liberty. Faith leaders are organizing "know your rights" training, labeling buildings as private property, and providing pro bono legal support. During Trump's first term, over 800 churches offered sanctuary, and leaders expect a similar response now. Despite fears, some leaders believe the policy will only target serious criminals, while others prepare for the worst. At least one arrest has occurred on church grounds, highlighting the potential impact of the policy change. Prominent faith leaders, including Pope Francis, have condemned the administration's approach to immigration.

25 members of Venezuelan gang Tren de Aragua arrested by ICE

- On Monday, January 27, ICE arrested 969 individuals, including 25 members of the Venezuelan gang Tren de Aragua and a convicted member of MS-13 in Dallas. The Trump administration, emphasizing consequences for illegal entry, aims to launch the largest mass deportation operation in U.S. history. Despite a focus on deporting violent offenders, officials have acknowledged that non-criminal immigrants are also being deported. Homeland Security Secretary Kristi Noem participated in enforcement operations in New York City, witnessing both criminal and civil actions. White House press secretary Karoline Leavitt defended the measures, stating that anyone entering the U.S. illegally is considered a criminal by the administration.

- U.S. immigration agents conducted a raid at a Newark, New Jersey, worksite, detaining both undocumented migrants and American citizens, including a military veteran. Mayor Ras Baraka criticized the operation, stating that ICE agents failed to produce a warrant and violated the detainees' constitutional rights. The raid is part of President Trump's executive orders aimed at clamping down on illegal immigration. White House spokesperson Karoline Leavitt reported that 538 individuals were arrested, including members of a Venezuelan prison gang and convicted sex offenders. Newark, a city with sanctuary policies, has been at the forefront of resisting federal immigration enforcement. Studies show that immigrants, including those undocumented, do not commit crimes at higher rates than native-born Americans.

Navajo Nation leaders raise alarm over reports of Indigenous people being questioned and detained during immigration sweeps

- At least 15 Indigenous people in Arizona and New Mexico have reported being stopped, questioned, or detained by federal law enforcement during immigration raids, causing panic in tribal communities. The Trump administration's increased efforts to arrest undocumented immigrants nationwide have led to confusion and fear among Diné/Navajo and other Indigenous people, with some detainees being asked to produce proof of citizenship. Navajo Nation officials are investigating the incidents and advising community members to carry state-issued identification and tribal documents. This situation has reopened wounds for Indigenous people who have long faced systemic injustices and underscores the importance of maintaining respect and dignity for all individuals, regardless of immigration status.

Trump eyes asylum agreement with El Salvador to deport migrants there

LAKEN RILEY ACT

- The Laken Riley Act is a piece of legislation named after Laken Riley, a 22-year-old nursing student who was tragically murdered by an undocumented immigrant in Georgia. The bill aims to address illegal immigration by mandating the detention and deportation of undocumented immigrants who are charged with certain crimes.
- Bill highlights include:
 - Mandatory Detention: DHS must detain non-U.S. nationals arrested for crimes like burglary and theft.
 - State Authority: State attorneys general can sue the federal government over harmful immigration policies.
 - Expanded Enforcement: Detention is required for noncitizens charged with or convicted of specific crimes, even without a conviction.
- The bill has bipartisan support but faces criticism over potential civil rights violations and excessive power to state attorneys general. It has passed the House and is under debate in the Senate, with discussions on possible amendments.
- On January 20, 2025, the Senate passed the Laken Riley Act with a 64-35 vote.
- On January 22, 2025, the US Congress has passed the Laken Riley Act. The measure cruised through the House by a vote of 263 to 156. It now heads to the White House for President Donald Trump to sign into law.

New Immigration Law Signed By Trump Likely Unconstitutional

The Trump administration has also frozen millions in migrant aid funding, impacting Texas nonprofits. The pope emphasized that deporting migrants fleeing extreme conditions damages their dignity and leaves them vulnerable. Archbishop Timothy Broglio highlighted that targeting faith-based border work infringes on religious freedom.

'Major crisis': Pope Francis rebukes Trump mass deportation efforts By Anna Betts and agency, The Guardian, 2/11/2025

- Pope Francis has criticized the Trump administration's mass deportation efforts and immigration policies, calling them a "major crisis" that harms human dignity. In a letter to U.S. bishops, he urged against narratives that discriminate against migrants and refugees, and condemned measures that equate illegal status with criminality. Francis acknowledged the need for national security but emphasized that deporting those fleeing poverty and persecution damages dignity and leaves people vulnerable. He also criticized Vice President JD Vance's defense of deportations. Since Trump's second term began, over 8,000 undocumented immigrants have been arrested, with some held in federal prisons and Guantánamo Bay. Francis appointed Bishop Edward Weisenburger, an advocate for immigrants, as the new archbishop of Detroit.

Congress could more than double its border spending in new Senate plan

- Congress is considering a plan to allocate up to \$175 billion over the next ten years to expand the U.S.-Mexico border deportation system under President Trump. The Senate will review a budget resolution by Sen. Lindsey Graham, directing funds to increase detention beds, hire more Border Patrol and ICE officers, and complete the border wall. If approved, this funding would significantly boost immigration enforcement, particularly in South Texas and border regions, and more than double the current budget for Border Patrol and ICE. The resolution also proposes investments in state and local law enforcement to support the immigration crackdown. The plan includes additional defense spending and unspecified cuts to other government programs.

27 religious groups sue Trump administration to protect houses of worship from immigration arrests By The Associated Press, 2/11/2025

- More than two-dozen Christian and Jewish groups representing millions of Americans ranging from the Episcopal Church and the Union for Reform Judaism to the Mennonites and Unitarian Universalists — filed a federal court lawsuit Tuesday challenging a Trump administration move giving immigration agents more leeway to make arrests at houses of worship. The lawsuit, filed in U.S. District Court in Washington, contends that the new policy is spreading fear of raids, thus lowering attendance at worship services and other valuable church programs. The result, says the suit, infringes on the groups' religious freedom — namely their ability to minister to migrants, including those in the United States illegally. The new lawsuit echoes and expands on some of the arguments made in a similar lawsuit filed Jan. 27 by five Quaker congregations and later joined by the Cooperative Baptist Fellowship and a Sikh temple. It is currently pending in U.S. District Court in Maryland. The plaintiffs in the new lawsuit represent a vastly larger swath of American worshippers — including more than 1 million followers of Reform Judaism, the estimated 1.5 million Episcopalians in 6,700 congregations nationwide, nearly 1.1 million members of the Presbyterian Church (U.S.A.), and the estimated 1.5 million active members of the African Methodist Episcopal Church — the country's oldest predominantly Black denomination. Among the other plaintiffs are the Christian Church (Disciples of Christ), with more than 3,000 congregations; the Church of the Brethren, with more than 780 congregations; the Convención Bautista Hispana de Texas, encompassing about 1,100 Hispanic Baptist churches; the Friends General Conference, an association of regional Quaker organizations; the Mennonite Church USA, with about 50,000 members; the Unitarian Universalist Association, with more than 1,000 congregations; the United Synagogue of Conservative Judaism, with more than 500 U.S. congregations; and regional branches of the United Methodist Church and the United Church of Christ.

Lawyers helping migrant children facing deportation ordered by Trump administration to "stop all work" By Camilo Montoya-Galvez, CBS News, 2/19/2025

- Legal services groups representing thousands of migrant children facing deportation were ordered by the Trump administration to halt their government-funded work, affecting around 26,000 children across the U.S. The Acacia Center for Justice, with nearly 100 subcontractors, received the directive, which stops funding for "know your rights" sessions and legal screenings. Legal groups protested the decision, arguing it leaves children vulnerable in the immigration system. The administration is also tightening the vetting process for sponsors and expanding collaboration between the refugee agency and ICE. Critics argue these actions will discourage sponsorship and leave unaccompanied children at risk of exploitation and trafficking.

U.S. pauses immigration applications for certain migrants welcomed under Biden By Camilo Montoya-Galvez, CBS News, 2/19/2025

- The Trump administration has indefinitely paused immigration applications from migrants from Latin America and Ukraine allowed into the U.S. under Biden-era programs, citing fraud and security concerns. This affects migrants in several programs, including the Uniting for Ukraine policy, which brought in approximately 240,000 Ukrainians, and the CHNV program, which allowed 530,000 Cubans, Haitians, Nicaraguans, and Venezuelans into the U.S. The pause affects migrants who were applying for benefits like Temporary Protected Status, asylum, and green cards. The directive was issued by USCIS to address fraud and national security concerns, impacting migrants' ability to move into another legal status.

New Immigration and Customs Enforcement data shows administration isn't just arresting criminals By Laura Strickler, NBC News, 2/19/2025

- The Trump administration has promised to prioritize the "worst first" in deportations, yet more than 1,800 detainees without criminal convictions or pending charges were added to ICE custody in the first two weeks of February, comprising 41% of the 4,422 new detainees. During fiscal year 2024, the Biden administration made 113,431 immigration arrests, with only 28% involving individuals without criminal records. ICE detention centers are nearing capacity, with detainee numbers rising from 39,238 to 41,169 in mid-February. Only 13% of current detainees face expedited removal, while the rest await lengthy deportation proceedings amid a 3.6 million case backlog in immigration courts. The Trump administration plans to transfer up to 30,000 detainees to Guantanamo Bay, having already moved 112 individuals. Recent data shows a rise in detainees with criminal charges to over 16,500 and highlights ICE's focus on alleged criminality in public messaging. The majority of new detainees are male, with only 22 females booked in the past two weeks. ICE has also ceased tracking the number of transgender detainees.

Soldiers are arriving at the border — but hardly any migrants are crossing

- 3,600 active-duty soldiers (U.S. Army and Marines) sent to patrol the U.S.-Mexico border. Border Patrol agents in Del Rio and Eagle Pass apprehending fewer than 50 people a day since late January, compared to 5,000 daily in 2023. Illegal crossings plummeting due to Mexico's enforcement and Biden administration policies. Border apprehensions expected to drop to fewer than 300,000 in 2025, a level unseen since 2017. Troops helping with border barriers, intelligence on cartel activity, and reinforcing security. Texas migrant shelters nearly empty due to the drop in crossings. Nonprofits shifting efforts to facilities and partners in Mexico.

The latest on Trump's immigration crackdown — and the reality of limited resources

- Recent Actions and Arrests
 - Since taking office, Trump's administration has seen 8,768 arrests (as of Feb. 3).
 - o ICE targets 1,200-1,400 arrests daily but achieved only 1,179 on Jan. 27, dropping to 300 by early February.
 - Arrests have been taking place in several major cities, including New York, Chicago and Denver.
 - DHS aims to deport 2,700 immigrants daily to meet Trump's goal of deporting "millions and millions."
- Deportations and Logistics
 - 5,693 deportations as of Feb. 3.
 - o ICE's average cost during the Biden administration for deporting a single person was about \$10,500, including arrest, detention and the deportation flight.
 - Current capacity: 41,500 detainees at 106 facilities, costing \$57,378 per bed annually.
 - o Administration wants to use Guantánamo Bay for up to 30,000 migrants; 112 already detained there.
- Resource Limitations and Costs
 - ICE operating under the same budget as of Jan. 19 (\$9.4 billion for FY2024).
 - o In a 2023 budget hearing testimony, the acting ICE Director said deportation flights cost \$17,000 per flight hour for 135 people deported and last about five hours.
 - Republicans propose \$175 billion (Senate) and \$110 billion (House) for border security and immigration.
- Administration's Strategy
 - Expanding manpower by involving IRS, FBI, DEA, and other agencies.
 - Deputizing IRS agents to investigate employers hiring illegal workers.
 - Military and ICE Air flights used for deportations.
